Saulius Paukštė(Kikfu-22): Looking at the 1.1 point, you mentioned that a few of the module laboratory works are changing into practical works. Do you know which modules are changing?

Answer: Not currently, no.

Question extension: How many modules are changing?

Answer: We know that several modules are changing.

Question Extension: When are they changing?

Answer: We don't have a very clear assumption on when, but we hope that next year

the changes will be implemented.

Artūras Medeišis (EF Dean): You mentioned a few surveys, conclusions. What do we, as the administration, are doing well or bad? How could we improve our work? Perhaps you could comment that there were any shortcomings from us?

Answer: One of the most recent surveys was about the final baccalaureate work tutors, recently we forwarded the results to you, we haven't received any feedback from you. The biggest result was achieved and the most effort was dedicated to the General Study Program Review. A grand total of 61 students took part and told their opinion, we have forwarded the information to you, the administration. Some students have mentioned that positive results are already noticeable.

Question extension: Do you think the deanery is doing a good job?



Answer: Yes, at least right now – everything is good.

Saulius Paukštė(Kikfu-22): As in the 1.1 mentioned point about final work surveys, don't you think that it would be necessary to share the results with group representatives and contact persons 4th years? Me, as a 4th year contact person, I would want to receive that information and share it with my group, and I'd assume I'm not the only one.

Answer: Because in the 4th year, studies start in November, the plan was to share that information with the administration and at the start of November, share it with 4th year group representatives & contact persons.

Question extension: As far as I know, there were only 12 answers. Why do you think there was so little activity and how will you avoid that the next time?

Answer: As I was a 4th year student myself, we were a little late with publishing the survey, after that students lost their student emails and it is likely that they couldn't reach the survey.

Saulius Paukštė (Kikfu-22): In the spring, Students' Representations of every faculty received comments from the Control Commission (perhaps 4.4 point) You mentioned, that you invited them to meetings, did we take notice of any of their comments, how we should change our activities?

Atsakymas: We received no bad comments, we had a meeting in October, we exactly received a comment that we are one of the most progressive representations.
